INTERVENTION - ROOM 108

3. Inappropriate behavior will result in you being sent from the Intervention Room to the Dean's Office.
4. Lunches are available for purchase. You may purchase a lunch in the Intervention Room or bring a lunch from home, order forms are provided in the morning.

General Rules:

- Every student leaving the room **MUST** have a pass. **Only passes from the Dean, Counselor, Social Worker, and/or Administrative Personnel will be honored.**
- There is to be absolutely no eating in the room other than at the lunch break.
- There should be **NO cell phone use, music playing, card playing, locker passes, sleeping or note passing.**
- Students given a pass must report immediately to that person, any student found wandering the halls will be subject to immediate disciplinary action.
